Terms

In exchange for a subscription fee of \$200, or \$280 with delivery, Prairie Smoke Farm will provide one (1) floral arrangement each week to each of its CSA members. The subscription period begins in midsummer and runs approximately July 24, 2023 through September 11, 2023 (a total of 8 weeks).

Payment

CSA memberships must be paid in full **no later than May 22, 2023.** If not paid in full by that date, you will not be a member and will not receive arrangements. Thank you for understanding that we cannot offer refunds. If you have made a purchase and no longer want to receive your share, you may donate your arrangement to a charity or organization of your choice.

General Expectations

- 1. I understand that the arrangement will be composed of a variety of seasonally available materials and that no specific flowers, colors or varieties can be guaranteed. (What we can assure is that your arrangement will be unique and beautiful.)
- 2. I understand that none of the materials used in the arrangements are intended for edible or topical use. I understand that some materials may be irritating or toxic if ingested by humans or other animals, and I agree to hold Prairie Smoke Farm free of any liability related to the misuse of the materials. If I have any questions, I will ask them as soon as possible.
- 3. I understand that my arrangement is a living entity and vase life cannot be guaranteed. (However, the farmers do their best to ensure as long a vase life as possible harvesting early in the day, chilling and hydrating/feeding flowers, etc. and will provide information on taking care of your arrangement to ensure the longest possible vase life.)
- 4. If I am dissatisfied with the product or service, I will share my feedback constructively and give Prairie Smoke Farm the opportunity to make it right.
- 5. I understand that by becoming a member I am sharing in the risk and rewards of the growing season. I realize there is an element of unpredictability with pests, disease, weather, acts of god and other unforeseen circumstances that may contribute or detract from the production of materials, and I agree that my arrangements may be subject to these factors.

Pickup / Delivery Expectations

Pickup Subscriptions: Missoula Farmer's Market (534 N. Higgins) on Tuesdays from 5:00 PM to 7:00 PM

• I agree to arrive at my pick-up location within the listed times and understand that the farmers may not be able to wait past the designated time. If I am unable to pick up my arrangement on the designated day or I do not contact the farmers to make alternate arrangements before the scheduled day I agree that my arrangement may be forfeit as a result.

Home Delivery Subscriptions: Mondays between 5:00 PM and 7:00 PM

• I understand that arrangements will be delivered as a wrapped bouquet with a small amount of water to keep them fresh in transit. If I am unable to receive the bouquet at the time of delivery, it will be left at the door.

Business Delivery Subscriptions: We will contact you to arrange a weekly delivery schedule.
